She gives her students an opportunity spend the day shadowing teachers, volunteering as tutors with the Fairfield Latchkey program, participating in food and clothing drives, completing yard work and making holiday cards for elderly residents of the Fairfield community, delivering notes of appreciation to staff and teachers for Teacher Appreciation Day, volunteering to work the CTE booth at the career fair to promote DTE, and seniors have the chance to test their skills by teaching a third-grade class. She will be recognized at a later event. Present to receive compliments were: Teacher of the Year Nominee, Nicki Wright, Delaware Area Career Center, Delaware, Ohio serves at-risk and disadvantaged students. Her program provides students with academic intervention, employability skills, career exploration, implementation of a career plan, work-based learning, and participation in a career pathway with options for both further education and jobs. 

(2) <u>The ESEA/NCLB/WIA/Education Reform Taskforce</u> to address all concerns related to these laws. The FY 10 Budget has not been accepted yet by the Congress. Perkins will be level funded; ARRA/Stimulus money is making it into the economy; Race to the Top grant requests are being processed; WIA funds will fund displaced workers, youth, and youth programs; and SAFRA is causing us to reevaluate Congressional priorities and new funding avenues (i.e. labor and green energy). Members are encouraged to visit the "Issue Briefs" section of the ACTE website. Annie reminded members to visit the ACTE 2010 National Policy Seminar pages on the website and register to attend March 8 – 10, 2010.


