## Legislative Committee Report by Rusty Black Missouri ACTE Legislative Committee Chair

Advocacy – that word certainly sounds better than "you will be going to the Hill tomorrow to LOBBY for Career and Technical Education." Both phrases mean the same thing to most of us except maybe when someone is "doing it" for us, the word is "advocacy" and when someone is "doing it" for some cause we do not have a passion for, we commonly use a word that seems negative. I have not forgotten the Presidential race and the negativity about lobbyists, but maybe it is appropriate to hire advocates.

It is very easy to see in this issue that your Missouri ACTE Leadership believes strongly in advocacy-at the state and national level. During National Career and Technical Education Week, many Missouri ACTE leaders and members traveled to Jefferson City to ADVOCATE for your programs. This time is spent not only discussing the local program with your legislator, but also identifying the importance Career and Technical Education has throughout our great state. Missouri legislators recognize the importance of our programs but in today's world, with all the lobbying going on, we must advocate for our programs. Missouri ACTE believes the teachers in local programs can provide the greatest story and the real passion for what each of you do - day in and day out.

This story must also be told at the national level. The members that attend the National Policy Seminar provide this local impact at the national level. Many of you may consider this activity as a waste of time and money. I very strongly disagree with this philosophy. In many cases, the legislative aids that help our legislators gather information and make decisions have little to no experience with Career and Technical Education. When your fellow members advocate for your program, they must in some cases first educate the aids about your role in education, the economy, Perkins funding and several other pressing issues of the day. When you are lucky and the staff is consistent, the meetings focus on the issues – when the staff is new – well, do you think everyone knows what we do?


A very common focus when discussing advocacy with our professional advocates (many call them lobbyist) is the theme -Know your legislators, talk to them regularly, make consistent contact with their staff. Those of you who know me recognize my weaknesses but also know I enjoy meeting people and discussing Career and Technical Education. I have tried to advocate for you whenever possible. I have been fortunate in the last 60 days to meet with Representative Sam Graves at a meeting in Kansas City. The week of spring break for our Missouri Legislators, Senator Lager and Representative Lair visited our local Technical School and Ag Department. March 9th, I was lucky enough to

chauffeur Senator McCaskill from our local airport to my classroom and back to the airport. No, we did not solve the world's problems, no guarantees of an endless supply of money to Career and Technical Education. I have known the first three for several years. We don't always agree, but we can always talk and respect each other's opinions and decisions. I enjoyed the opportunity to meet Senator McCaskill. She was very gracious and kind. Many of you know her office took the lead role in our Social Security issue. I was pleased to relay Career and Technical Education teachers' "thank you" for advocating on our behalf.

Advocacy begins with you. The attitude we display for our job, students, school and profession tells a story. Please tell a POSI-TIVE story.

I would like to thank you for the opportunity to serve as Legislative Chair for Missouri ACTE. This organization is fortunate to have a staff of dedicated professionals serving the members. Donna and Margie work diligently to meet members' needs and concerns with limited resources. Sarah dedicates herself to our students with passion, not a dollar-per-hour attitude. The next time you wonder if your dues are worth it, or the teacher next door decides not to support our organization by paying their dues, call me. I will advocate to YOU.

Chelonnda Seroyer is a high school English teacher in Madison, Alabama. She used Dr. Wong's book, The First Days of School, as an "instruction manual" to set up her classroom and consequently had a very successful first year. At the end of her first year of teaching, she was awarded the "Bob Jones First Year Patriot Award." This award is given to the first year teacher in recognition of outstanding accomplishments and achievements in Academics, Athletics, or Co-Curricular pursuits. At the end of her second year of teaching, she was awarded the "Patriot Award." This award is given to a faculty member in recognition of valuable contributions, dedication, and service to the educational community. At the end of her fourth year of teaching, the first year that she was eligible because she was newly tenured, she received the "Teacher of the Year" award. She has also received the Toyota International Teacher Award. This award was given to 40 teachers from around the country. The teachers traveled to Japan for an educational study tour of the country and its educational system. While in Japan, she was featured on the lapanese national news station while discussing her plans to bring the Japanese culture into her classroom.

Chelonnda is a very active member of the Bob Jones faculty and has been placed on several committees. She

has been selected to be a part of the Building Based Student Support Team (a committee that has been established as part of the "No Child Left Behind" mandate), the Renaissance Rewards Committee, and the Alabama Reading Initiative team. She is a "Madison City Schools Technology Certified Teacher" and she has also received her "Master Technology Teacher" certification from her school district. Chelonnda is also an executive member of the Madison City School's New Teacher Induction Team where she, along with central staff personnel, coordinates the induction program for new teachers coming into the school system.

She has presented with Dr. Harry Wong for organizations such as the New Jersey-ASCD conference, the 2005 and 2006 NASA/NSU Pre-Service Teacher Conferences, and the Miami/Dade County Schools New Teacher Conferences. She is one of the featured teachers in Dr. Wong's online classroom management course and her complete story was featured in a February, 2005, <a href="https://www.teachers.net">www.teachers.net</a> column. Chelonnda is also featured in the brand new 4th edition of Dr. Wong's bestselling book The First Days of School.



## FCCLA Legislative Shadowing Project

More than 70 Missouri high school students received an inside look at a day-in-the-life of a state official on February 25 in Jefferson City. The Missouri Family, Career, and Community Leaders of America (FCCLA) Legislative Shadowing Project pairs juniors and seniors with state representatives, senators and other officials to observe their meetings, hearings and public duties.

Shadowing allows students to connect their interests in laws, public service, civic issues and the political process with their education. By the end of the day, students developed a better understanding of the political process and its impact on citizens.

Marcia J. Ritter, CFCS, Missouri ACTE Legislative Committee member, serves as project coordinator. Marcia attempted to match students with officials from their districts. Once matched, the student prepares by becoming familiar with the official's responsibilities and current issues. If matched with a legislator, the student becomes knowledgeable about the bills introduced and committees on which the legislator serves.

The students and advisors arrived in Jefferson City on February 24 to participate in tours of the Missouri Supreme Court and Missouri Capital. That evening, Missouri Supreme Court Judge Mary R. Russell addressed the group during their orientation session. She promoted civic awareness and challenged the students to focus on critical thinking and problem solving in relation to their future goals and career exploration.

The students and their advisors gathered at the end of the shadowing day to evaluate the day's events. Upon return to school, they prepared summary reports and are responsible for communicating their experience to other students, their school boards and community groups. The Missouri Educators of Family and Consumer Sciences financially supports this project and provides the students with professional binders/folders for their visits.

## National Policy Seminar ... You Really Should Go

I was given a wonderful opportunity to travel to Washington, DC in March to experience the National Policy Seminar for ACTE. Not knowing what to expect once I got there was rather intimidating. Ronald Regan airport is a challenge all to itself, let alone what lay ahead for me.

There were meetings that we attended to learn about how to actually talk and converse with our representatives in Washington, DC. I had not realized there was an actual "science" to do so. I participated in Capitol Hill 101. We learned the fundamentals needed to be successful advocates for CTE. We learned an overview of the Congressional processes and terminology, what to expect during the conference, how to make the most out of visits to Capitol Hill during the meeting and what to do after returning home to our districts.

Our keynote speaker was Stanley Collender who has extensive experience on Capitol Hill and is considered to be one of the leading experts on the U.S. Budget and congressional budget process in Washington.

The General Sessions were so informative for the Career and Technical Educator. Those included: The Future is

Now: Laying the Groundwork for Perkins V, ACTE Issues Briefing, State Planning Round Tables, Opportunities in the New Congress, Effective CTE Messaging in the New Political Environment, Expanding Opportunities Breakout Sessions on Health Care Policy, Energy Sustainability and "Green" Policy Issues and CTE and the Research Agenda.

The Closing General Session which was entitled Opportunities in the New Administration included a Keynote Address from Secretary of Education Arne Duncan. That was the first time that the Secretary of Education has ever made an appearance at the National Policy Seminar. I got the opportunity to see him and listen to him and his vision for education. The experience was awesome.

Along with the meetings, we were scheduled to meet with our legislators "on the Hill." In Missouri, we met and decided who would visit whom. We went in groups of roughly five or six. ## Missouri DECA State CDC Sets Attendance Record

A record number of 1,500 high school marketing students emerged for the annual Missouri DECA State Career Development Conference (March 22-24) at the Lodge of Four Seasons, Lake Ozark.

The high turnout reflects the steady growth in DECA membership. Missouri passed the 10,000-member milestone this year, due to a successful membership campaign. Missouri DECA is only the fifth state to reach this level.

DECA is an international association of high school students studying marketing, management and entrepreneurship in business, finance, hospitality, and marketing sales and service.

"Through classroom instruction and DECA activities, our members are learning to become savvier in today's economy and acquiring knowledge to advance their studies in marketing, management and entrepreneurship," said Christopher Young, state advisor for DECA and supervisor of DESE's Business, Marketing and Information Technology section.

"DECA provides an avenue for students to develop essential skills for a successful career and gives them an edge in a competitive job market. DECA's goal is for students to use these skills as a catalyst for contributing to our economy," he said.

International DECA officer, Isaac Robinson III, greeted students and their teachers. Robinson was a member of the McCluer North High School DECA chapter, Ferguson-Florissant School District. He is now a freshman at Truman State University and serves as DECA Central Region Vice President.



Students tested their skills in 40 competitive events related to real-world topics such as entrepreneurship promotion, Internet marketing, financial analysis, buying and merchandising, food marketing sales and hospitality services. A new chapter team event this year is the Financial Literacy Promotion Project.

The individual, team, and chapter projects were judged by 120 professionals from the business community.

"Even though our judges' volunteerism is priceless, we estimate that their collective contribution of time translates to a value of more than \$15,000. That's a stellar contribution to Missouri's future from these corporate professionals," Young said.

Winners at the state conference will advance to international DECA competition that will be held April 28 - May 3 in Anaheim.
