# xiii. Special Populations

# **b.** ACTE Committee Reports

# i. Bylaws

Sherry reported that the ACTE Bylaws committee presented a new Policy Manual template to the Board of Directors. Brenda Conell will transfer the existing NRS Operating Policies into the new template and then present it to the membership.

Sherry also reported that the following bylaws changes were approved during the Assembly of Delegates session:

- Article 3 (Membership): The name of the "Associate Membership" category was changed to "Corporate Membership" to remove the confusion of this category for businesses.
- Article 4: (Organizational Structure): The "Emerging Division" category
  where 200 members constituted an emerging division was eliminated.
  The result was a threshold of 25 members for sections and 750 members
  for divisions.
- Article 8 (Committees): Language related to standing committees in general and specifically for the Nominating committee was removed – this language still said that divisions with at least 1,000 members would be represented on the committee. This corrected the previous oversight of this language which should have been changed when division membership thresholds were changed to 750 in 2011.

Sherry reported that the following bylaws changes were NOT approved during the Assembly of Delegates session:

 Article 7 (Election of Board of Directors): This proposal required members running for division or region Vice-President to be interviewed by the appropriate nominating committee. It stipulated that members who were not interviewed could not run from the floor.

# ii. Nominating

Sherry reported that two candidates are running for ACTE President-Elect:

- Lorri Carlile, Region IV
- Chuck Gallagher, Region V

# iii. Resolutions

Sherry reported that the following resolutions passed at the Assembly of Delegates session:

- Perkins Reauthorization
  - The first resolution stated that ACTE supports a noncompetitive formula-funded grant structure as the basis for the next Perkins reauthorization.
  - The second resolution stated that ACTE supports making State Leadership Funds available in future reauthorizations of the legislation.
- The third resolution stated that ACTE encourages the inclusion of CTE language in STEM-related grants being released throughout the country.

# 4. New Business

## a. Membership

- The October 2014 New and Related Services membership count was 2,294 members and was 26,173 members for ACTE overall.
- During 2014, eleven of sixteen NRS sections had an increase in membership, two sections remained constant, and three sections had a slight decrease in membership (the maximum decrease was six members).
- The NRS section with the highest number increase in membership was the "Other" section with 58 members and the section with the highest percentage increase was Public Information with a 70.8% increase.
- The School-to-Work/Career section transitioned from NRS to the Guidance division. This section had 195 members.
- The Special Populations section transitioned to NRS and joins the division with approximately 600 members.

## b. Virtual Participation

The members present discussed the value of meeting and voting virtually. Sherry reported that several Vision sessions were recorded this year as an attempt to offer professional development at a reduced cost to those unable to attend the

conference in person. The recorded sessions be available free of charge to all registered Vision 2014 attendees and for a fee to all others interested.
