Call to Order Welcome Introductions

President Janet Goble called the meeting to order at 5:04 PM CST and thanked those in attendance. VP-Elect, Patrick Biggerstaff, was introduced.

Affiliate Updates

National Council of Local Administrators: Dave Keaton

- We had a great Best Practices meeting in Albuquerque, New Mexico with over 400 in attendance. Next year's conference will be in Louisville, Kentucky, September 26-28.
- #NCLAchat is a Twitter "chat" that focuses on current issues pertinent to the role of the CTE administrator.
- NCLA awards two Berryman scholarships (new attendees are eligible for complimentary conference registration and \$750 travel stipend) that are given each year to CTE administrators that attend the BP&I in CTE Conference.
- Extensive work on website as part of the new branding highlights membership, scholarships, the name change strategy which is like FFA, and the social media presence using Twitter.

Career and Technical Education Equity Council: Jeanette Thomas

- Just had business meeting where new officers were slated so the new president, Twyler Earl, will tell you about CTEEC.
- Twyler asked the group if they knew was CTEEC is? A group of professionals
 that help with equity and access across special populations with a unique focus
 for students that are under employed including TANF for disadvantaged
 students that are seeking to gain self-efficiency and those suffering from
 mental health and chemical dependency and addiction.
 - o Highlights from the annual conference were shared.
 - Ben Williams, from the National Alliance for Partnerships in Equity, was introduced.

Legislative Issues

Steve DeWitt, ACTE Deputy Executive Director

- ACTE activities BOD just approved a new strategic plan prioritizing the next few years. The five themes addressed in the strategic plan include: member value and engagement, professional and leadership development, advocacy and awareness, strategic partnerships, and innovation.
- ACTE is also working on four content priorities and is focused on building content around these priorities to support members:
 - o Employer-Educator Connections
 - Career Pavilion/Trade Association Conversation
 - Sector Sheets (Pearson sponsor) snapshot of high skill/high need areas (providing a mailing to over 5,000 school counselors via Pearson sponsorship)
- Four (4) Industry Insider Tours launching this year info to be released soon
- Middle School CTE/Career Development (Xello sponsor)
 - Career Exploration in Middle School: Setting Students on the Path to Success publication
- Teacher Educator Pipeline teacher "skills gap"
- Administrator Support
 - New book series for administrators (NOCTI partnership)
 - Free online course via CTE Learn (Project Management Institute Educational Foundation sponsor) - Currently 4 modules are available. 5 will be ready in the spring; go to ctelearn.org for listing of courses being offered.

Alisha Hyslop, ACTE Director, Public Policy

- Overseeing advocacy and research, Perkins and policy issues
- Policy challenges: Please let ACTE staff know if you have policy challenges, members are critical to our issues. For example, post 9/11 GI Bill has had issues that members alerted us to and finally got fixed five years later;
- Four big issues related to CTE Perkins Reauthorization House bill passed in June, waiting on Senate, not talking right now so it is a waiting game for action, Secretarial Authority is spilling over from ESSA and is impacting Perkins (and higher education as well);
 - The fiscal year 2018 Year Continuing Resolution Funding December 22
 Extension no agreement for spending caps for discretionary spending (domestic and defense). They must reach an agreement on spending caps before this can move forward.
 - Tax Bill Both the House and the Senate have approved and want in place before the end of the year. Education provisions include the

teacher supply and materials deduction (\$250). House would eliminate. Senate doubled it to \$500. ACTE is advocating for Senate position.

- Student loan interest deduction and employer-provided tuition deduction eliminated in House bill.
- SALT (state and local taxes) are currently able to be deducted. House bill proposes \$10,000 for property taxes and none of the others. Senate bill put back the property taxes piece at the last minute, but still none of the other taxes either.
- Higher Education Act Reauthorization Comprehensive piece of legislation came out Friday, December 8 from House Republicans. Quite extensive (500+ pages). Financial aid options are consolidated to one PELL grant, work study, and student loan; significant cuts in financial aid; ACTE is optimistic related to issues in CTE but concerned about cuts in financial aid and quality overall; mentioned Jobs Act related to PELL; work-study, apprenticeships (WBL) positives; all teacher development grants have been dropped and eliminated.
- Dave Keaton from Maine asked about Methods of Administration reviews by the state office. These are not part of Perkins specifically, but instead part of federal civil rights laws. Jeanette Thomas stated that the gentleman should reach out to his regional OCR office if you have a concern or need assistance.

- The Vice President-Elect
- One designated representative from each of the ACTE standing committees
- The executive director of the ACTE
- One designated representative from each of the affiliated and section organizations of the division
- A representative from United States Department of Labor
- A representative from the US Department of Education

Officers of the Policy and Planning Committee:

Chairperson - the Vice President of the division shall serve as chairperson of the Policy and Planning Committee throughout tenure in that office and shall appoint a secretary from the committee membership. The chairperson shall preside and direct the affairs of the committee.

NCLA Report to the Policy Committee of the Administrative Division of ACTE December 2017

The National Council of Local Administrators of Career and Technical Education was formed in the 1940's as a vehicle to serve the needs of the local CTE administrator. NCLA is governed by a board of CTE administrators representing ACTE's five regions and CTE administrators at large. NCLA is legally incorporated in the state of Florida. Tom Applegate, former national ACTE board member and national ACTE president serves as the executive director. NCLA is an affiliate of the ACTE Administrative Division

Within the last year NCLA undertook a process to look at its core mission and purpose and to realign it with the needs of CTE administrator. As a result of the process we have dropped the name National Council of Local Administrators and assumed our name as NCLA. This is similar to what FFA did in dropping Future Farmers of America as its name and adopting FFA. We have established the following as our focus and mission:

At NCLA we believe we're better together. As a national synergy of CTE administrators we connect forward-thinking educational professionals, contribute to the nation's economic prosperity and create opportunities for transformational professional development.

Through next-gen ideas, innovations and best practices we bring national solutions to local challenges-building a future of shared excellence. Together we are changing the CTE paradigm and improving the outcome for our students, organizations and communities.

Current Initiatives

Our major initiatives include:

A yearly Best Practices and Innovations in CTE conference. NCLA developed the
conference in 2006 and invited national ACTE to join us as a co-sponsor in 2008. We
have enjoyed a successful relationship over the past 10 years and look forward to
continuing the relationship with ACTE. Strong programming has made this conference a
premier professional development event for the CTE administrator. The conference is
intended to be a boutique conference allowing CTE administrators the opportunity
share ideas as well as to create and/or expand their professional network. This past
year's conference held in Albuquerque, New Mexico in September, brought in over 400
attendees. Next year's conference will be in Louisville, Kentucky –September 26-28,
2018.

- New this year is our monthly NCLAchat. The web based "chat" focuses on current issues pertinent to the role of the CTE administrator. The moderated "chat" pre-discussion questions are distributed to all NCLA members.
- Each year NCLA awards two Berryman scholarships to CTE administrators to attend the Best Practices and Innovations Conference. The scholarships are for administrators who haven't previously attended a Best Practices Conference. The scholarships include complimentary conference registration and a \$750 travel stipend.
- The webpage for NCLA is newly re-designed and can be viewed at ncia-cte.org Information regarding applications for the Berryman Scholarship and other important NCLA can be found on the website.
