Centered on the Vision 2012 theme of *student engagement and success*, our division's three Deep Dive sessions will begin with "Achieving Student Engagement and Success through Comprehensive Guidance & Counseling Programs," an overview of the essential guidance and counseling program elements that can contribute to the successful implementation of CTE and academic programs of study and the overall career development of all students.

Moderated by division Vice-President and Missouri School Counselors Association Executive Director, Dr. Lee Bunch, this presentation will feature the foremost experts in the nation on guidance: Dr. Norman C. Gysbers, Curators' Professor, Counseling Psychology University of Missouri, Columbia, Missouri; Dr. Bragg Stanley, Director of Guidance and Counseling, Missouri Department of Elementary and Secondary Education; Judy Petersen, Director, College and Career Readiness, Granite School District, Utah; and Steve Beutler, Career Counselor, Minot Public Schools, Minot, North Dakota.

This two-hour panel will be followed by two "break-out" sessions that will immerse attendees in enriching professional development regardless of one's role in guidance. The first, "Measuring Student Engagement and Success through Building an Evaluation Capacity System for Comprehensive Guidance and Counseling Programs," featuring Dr. Gysbers and Dr. Stanley, will deliver critical components of guidance accountability...a timely presentation as we face increasing accountability requests for LEAs and at the state and national level. The second break-out session will be "Creating and Enhancing Student Engagement and Success through the use of Career and College Readiness Plans," featuring Ms. Peterson and Mr. Beutler, sharing cutting-edge activities, technology, and programming to enhance school-based guidance.

All three Guidance and Career Development Deep Dive sessions will enable attendees to leave Atlanta more knowledgeable of local, state, and national issues that we face in delivering guidance and career development to support CTE programs of study. Minot, North Dakota schools host America's Empowerment Coach

"Yo Pal" Hal Elrod is often referred to as America's Empowerment Coach. As an International Keynote Speaker, Bestselling Author, Hall of Fame business achiever, National Champion Sales Leader and Ultra-Marathon Runner, Hal Elrod is considered by most leaders to have already overcome and accomplished more (before the age of 30) than most people do in a lifetime.

During Hal's keynote address he makes an impact on <u>adults</u> as well as teens. Hal shares his unbelievable true story of being hit head on by a drunk driver and found dead-at-the-scene of the accident at age 20! He encourages his audience to <u>LOVE</u> the life they have so they can <u>CREATE</u> the life of their dreams and achieve career success. Hal's "Taking Life Head-on Formula" is a road map for achieving this success. Hal also developed what he has termed "Can't Change It" philosophy in which he encourages his audience to <u>not dwell on the past</u> or the things they <u>can't</u> change in their life, but instead put their efforts into the aspects of their life they can control.

Hal made a huge impact on the North Dakota Students. Here is a sampling of what students had to say about Hal's presentation at Minot High School:

- You made me realize that I cannot change the past and that all I can change is my future.
- I just wanted to write to you and tell you how much you inspired me in all the things that you do and be living proof that absolutely anything is possible. Thank you so much.
- Yo Pal Hal was a great speaker, have him back next year!
- Hal is a good inspiring person and I believe he helped me with my life and who I can become.

The following is what Steve Beutler, Career Counselor, Minot Public Schools wrote for his Career Development Website to sum up the impact Hal made at Minot High School.

Hal's testimonial of his amazing recovery from his near death experience combined with his "Can't Change It" philosophy was an inspiration to all who attended the Minot High School, Central Campus Career Fair. His uncanny ability to encourage and empower students to create the life of their dreams made this career fair a life-changing event for many of our students. After dropping seeds during his keynote address, Hal's positive attitude became contagious and spread throughout Central Campus like wild fire during the week following the Career Fair. The new buzz word, "Can't Change It" has echoed throughout the school since the event. Thanks Hal for the impact you have made on our students!
