NCACTE Legislative Update Vol.2, Issue 1



Former Rep. Bryan Holloway looks forward to lobbying on behalf of the NCACTE.

With a background in teaching and farming, coupled with more than a decade of experience in the NC General Assembly, Mr. Holloway knows his way around Raleigh and will be a leading voice for the CTE community.

When the Legislature is out of session, Bryan will be on the road, meeting with lawmakers in their districts. When committees meet during the off-session, expect Bryan to be present at those meeting. He will also be working with CTE leadership as they craft their legislative agendas for the upcoming legislative sessions.
