In 2009, Carolyn initiated the implementation of this work based learning experience/partnership with the hospital to enrich the learning experience for the Early Childhood Students of the Harlem school district. 1. What problem was this partnership developed to solve?

This partnership provides the students with an enriched learning experience, while at the same time allowing them the experiences of "life on the job." This in turn creates a stronger workforce for the industry in this region. While the students have plenty of course work, they are also learning while assisting and experiencing the many challenges that come up day to day in this field.

2. What steps were taken to get the partnership started?

The founder of Ryan Jury and Instructor Ms. Knuth had relationship at a prior hospital. Ms. Knuth followed Carol Mittel to Swedish American and they partnered together in this program.

4. What were the results of the partnership? What was innovative about the partnership or its output? How did it benefit students and the community?

Students find out if this is a career field they want to pursue, before investing in education. As a result of this program their have been students who have been hired and are currently working at this hospitals Child Development Center.

Harlem High School is currently the only High School in the region offering this program to it's students. By the Harlem District offering this program, students are able to experience a daycare teaching experience which prepares them for possible career opportunities in this Child Care pathway.

The benefits of this program not only offer the student the exposure & experience in this field, but also in many cases provides this industry with experienced, seasoned employees.

5. What were the lessons learned during the process of building the partnership? What would you have done differently?

While the students have this experience with children, it allows them to discover if this is the pathway they will pursue; in addition, if provides opportunity with teaching, interacting with students and workplace skills, such as attendance, showing up on time, teamwork, professional dress and conduct. Students in this particular program are encouraged to purse an Associates degree for employment at this facility.

While Mrs. Knuth loves working with this facility, her desire it to find other entities who would offer this type of program, so more students could have this opportunity.

The hospital program is provided at no charge to the school district; Mrs. Knuth is offering this to her students as part of her teaching assignment. Students are required to pay for a TB test a minimum of two times. Otherwise, time and opportunity were the only requirements of this wonderful program.
