<u>Call to Order</u>: The ACTE Region I *Annual Business Meeting* was called to order at 4:00 p.m. by newly appointed ACTE Vice President, Nancy Trivette. A vacancy was created when previously elected Vice President, Robert Scarborough resigned from ACTE's Board of Directors for personal reasons effective Thursday, September 1, 2011. Nancy stepped forward to resolve the matter. She is currently with the New Jersey Department of Agriculture as Leader and FFA Advisor. ACTE approved her place in office at the Board of Directors Meeting earlier this week. She is thankful to everyone for all the help and encouragement she has received in preparing to take office. She emphasized for everyone, the benefits of two programs for personal and professional development —

(1) The purpose of the ACTE Fellowship Program is to:

help establish a leadership development program for CTE educators in ACTE and assist individuals in further developing their leadership skills in CTE and their involvement in professional associations

provide an opportunity for CTE educators to become familiar with and participate in the processes used by policymakers in the development and implementation of laws, regulations and other public policies at the local, state and federal levels

identify, train and motivate a cadre of leaders who will continue to position ACTE as a leader in developing an educated, prepared, adaptable and competitive workforce

(2) The program of work for the Leadership Training Program involves:

- > Mission, Goals, and Objectives
- Governing Body, Officers, and Directors
- Organizational Structure and Documents
- > Programs, Services, and Activities
- > Financial Planning and Reporting
- > Membership Development and Retention
- Communications
- Public Policy
- Association Operations

Both Fellowship and Leadership Programs have had good attendance numbers at convention.

Nancy specified her goals would focus on: (1) *Increase Membership in Region I* and (2) *Increase Communications*. She senses the excitement of the new ACTE initiative that will soon be announced. Membership continues to be an all important topic which should be on a priority list for all members.


NEW BUSINESS
