## Highlights from the report:

- Challenges with membership
- Continue to work with state associations to work together and overcome our challenges about membership
- MC spoke about STEM parent and ACTE resource for students and parents that helps with career exploration, planning with high engagements and virtual mentoring in High Demand, High Skill and High wage STEM careers
- Revenue sharing with states around this initiative for this service by using state codes with ACTE members
- ACTE secured a 1 million dollar grant with ACTE Fellowship for Post-secondary including a cadre
  of mentors, CTE Community College Presidents, and CTE Centers
- Participants will be eligible to receive a stipend and graduate credit
- Harbor Freight "Tools for Schools" (Another \$1 Million dollar grant) will award 20 teachers \$10,000-\$20,000, Finalists-\$30,000, and \$70,000 to winner and promote the skilled trades with this initiative
- Horacio Alger scholarship (2.5 Million in scholarships to 1020 award winners (Largest CTE scholarship
- Membership up to 23,500 for ACTE
- 50% of membership comes through states and 50% paid individually
- Attendance for VISION 2018 as of November 1 was 3876. Lower than last year (4102). Largest as of late was 4644 in Las Vegas, 2016. Attendance should go up over Nashville.

Financial report for Region II. Awards over budget by \$55.00. Brian Law continued to discuss financials for Region II and the ACTE budget broken down by region, including number of members, Policy Committee travel and encourage the group to be thinking about budget items that need addressing in a different manner. Discussed Region II Committee work including what Region II members are serving on various committees (i.e. Audit, Awards, Nominating, Resolutions, etc.)
