Since the last Board meeting, what have you and your policy committee members done to represent and serve your Region/Division members in the following areas?

Member Value & Engagement

Ex. Growing Membership // Engaging Members // Recruiting New Leaders // Developing Leaders

IL ACTE is working with their State Board as hosts of a new teacher academy. This is their second year and each year it grows. The State is using their Perkins Leadership dollars to send new CTE educators to their conference and special sessions that are held at the same time as the conference. **IN ACTE** is working with their Governor's Workforce Cabinet to give IN ACTE more dollars (likely doubling or more!) to create a statewide committee to work on Teacher Recruitment and Retention. They are utilizing their Health Sciences educators to work on policy for safe practices should they be able to hold their state conference face-to-face this fall. **WI** is working on getting a core group together this summer. Lisa has offered to join with them if she can be of assistance.

All states in our Region are committed to helping financially with data collection for continuing our Teacher Shortage initiative along with Region III operating budget this year. Nominating committee is ready to meeting mid-June to interview VP-Elect candidates. Region III will hold a Virtual Awards Ceremony and Business meeting June 25th. ACTE will be helping organize it.

Professional & Leadership Development

IA ACTE is planning for state conference in Sept. and two affiliates (one is re-booting this year so it is a way to connect right away) will be connecting to the conference. Scott Stump will be the Keynote. IA is excited to share that they have secured a location for the 2022 Region III conference in Downtown DM they are gearing up to start planning well ahead of time! **IL ACTE** is having Rachel Mann Keynote at the conference and do a closing and some sessions as well next February. They are also having SREB send speakers for the event. **MN ACTE's** annual CTE Works fall conference theme is a Bold Vision Beyond 20 a virtual conference. Still planning on mid-June 2021 Region III conference in Pryor Lake. **MO ACTE** is surveying the field about their late July conference that has upwards of 1200-1300 attendees in Spring MO. Affiliate MOFACS has been meeting virtually to give the field an idea of what that can look like and how they can still benefit if it is held virtually.
