- **Region I Vice President-Elect:** Serves a three-year term beginning July 2023.
- **Region IV Vice President-Elect:** Serves a three-year term beginning July 2023.
- **Engineering and Technology Education Division Vice President-Elect:** Serves a three-year term beginning July 2023.
- **Trade and Industrial Education Division Vice President-Elect:** Serves a three-year term beginning July 2023.
