### ACTE FCS Division VP Election 2022


It is time to start the process to run for the FCS Division VP. The election will take place beginning **December 3, 2021-January 3, 2022**. The three year position begins July 2022.

## ACTE Releases Report on CTE During and After COVID-19





## ACTE Student Trophy Design Contest Returns

## WBL Conference is Now Fully Virtual






