- Jan provided an update on the conference
- The CFP was open through December, but the planning committee have sent out additional invitations for folks to submit proposals to make sure that the session offerings cover all topics they would like to see
- The planning committee aims to decide on session offerings and send acceptances to presenters by the end of January / beginning of February
- Jan reiterated that it is important for policy committee members to try their best to attend the conference in April
  - $\circ$   $\,$  Jan offered to help if committee members need help convincing their admins, etc.
- The policy committee will meet on the evening of Wednesday, April 27<sup>th</sup> so policy committee members should plan to arrive by then
- Jan reviewed the link to the conference website
- Jan reviewed the schedule at-a-glance
  - Jan asked for volunteers to help with the "wake up with WBL" session on Thursday 4/28
    - Jim E. offered to help, but not lead the session; Tony May offered to assist as well
  - Kelli provided an update on sponsorship / exhibitor status; there are many folks knocking down the door to participate in the conference!
    - Kelli reminded policy committee members to encourage folks from their regions to visit the exhibit hall
    - Stephen asked if we could set the exhibitors in the lobby or hallway of the conference (rather than a room) so that folks will mingle with exhibitors more
      - Jan thinks that this will likely be the case
      - Stephen offered to help with the exhibitors
  - Kelli reiterated that ACTE strongly encourages that policy committee members attend the WBL conference
  - Jim E. it is important that the WBL section develop stronger connections with post-secondary members and asked Kelli if ACTE can help with this and leverage the fact that we will be at a community college for the conference
    - Laura offered to connect Jim with Dr. Sophia Alston, ACTE Postsecondary Fellow
  - Jan shared that there will be regional hospitality rooms again this year on Thursday 4/28 – regional reps will be responsible for activities in these rooms
  - Jan shared that there will probably be topic-specific tables at breakfast on 4/29 that will need facilitators (ex. WBL educators)
  - On 4/28 during lunch, there will be time for the committee chairs to present on their committees
  - On 4/29 during lunch, there will be a section meeting
    - There will hopefully be conversation about becoming a Division during this meeting (number is at 757 as of 1/5/22)!
  - The awards program will take place on Friday 4/29
  - Kelli reminded the group that there is a \$50 registration discount for presenters
