Purpose

To recognize the contributions and distinguished accomplishments of those persons who have been identified with the work and purposes of Region V.

Guidelines

This award will be presented to those persons who have been identified with the work and purposes of Region V and the Association for Career and Technical Education. The award will be presented to ACTE members who have made a significant impact on the field of Career and Technical Education, specifically at the Region V level, along with the national and state levels. Only one award may be presented each year, unless under unusual circumstances as determined by the Policy Committee.

The nominees will be evaluated on the following criteria:

- Impact of contributions on student achievement, curriculum, community, Career and Technical Education programs
- Significant contributions at the Region V, national, and state level
- Contributions or prominence achieved above and beyond job assignments

Eligibility

The award will be presented to distinguished persons who have been identified with the work and purposes of Region V and whose contributions have made a significant impact on the field of Career and Technical Education. Applicants must be a member of ACTE.

Application Procedures

All nominations must come from Region V ACTE members. Events should be dated and listed with the most recent first. All materials must be submitted electronically (ie. .docx, .pdf, or .jpg). Application with incomplete information AND/OR missing Letters of Support WILL NOT BE ACCEPTED.

Applications for this award must include:

1. Nominee Information
 - Name, Address, Email and Phone Number
2. Outstanding Accomplishments of the Nominee - On a separate sheet for each heading, please describe the following in regards to the nominee (limit to one page per heading):
 - **Impact of contributions**
 - i. Examples include: examples of student achievement, curriculum development, community involvement, and/or Career and Technical Education programs.
 - **Significant contributions at the Region V, national, and state level**
 - i. Examples include: Region V VP, Policy Committee, Committee Chair, Committee Member, Region V Fellow, Region V Special Assignments, Conference Presentations, National and/or State Leadership, etc.
 - **Prominence achieved above and beyond job assignments**
 - i. Examples include, but should not be limited to: honors and/or recognition, professional offices held, major publications, and professional memberships and/or activities
3. Letters of Support (minimum of 2, maximum of 4) and should be no longer than one page in length.
 - A letter of support is **recommended** from either the Executive Director or President of the state's ACTE organization
 - Other suggested endorsers might include: political leaders, professional association leaders, business and industrial leaders, educational leaders, civic leaders, parents and students.
4. Photograph of the Nominee

- Digital photo should be at least 300 dpi and in .jpg format. *(The photograph is used for publicity purposes only)*
