New Business

• The Proposed Budget for the 2021-2022 Fiscal Year (attached) was presented by Greg Krawiec and Sandy Warning. Matt May moved to approve the proposed budget; seconded by Kristen Bandy. Motion carried.

- Barb Schult moved to approve the 2nd Vice President nominations for Ashley Spannagel and Jeff Henderson; seconded by Kristen Bandy. Motion carried. The ballot will be emailed to the active membership within 15 days (by October 6).
- Greg Krawiec led a discussion on unification of Iowa ACTE dues and ACTE dues, proposing that the dues are
 required to be paid together, creating an affiliated and unified state with ACTE. The following points were
 made. It is a good practice to be members of both; IITEA is worried it will potentially lose members due to the
 added cost; ACTE offers a four-payment option to reduce the burden of paying the full amount; all affiliation
 groups need to work on actively promoting membership; do not tie membership to conference dates.
 - o Karen Van De Walle moved that our membership adopt a unification of Iowa ACTE dues and ACTE dues, both dues are required to be paid together; seconded by Kristin Bandy. A paper ballot was collected from 17 delegates present. The vote was Yes = 12; No = 5. Motion carried.
- Several delegates left the meeting at 5:00 due to travel required and there was no longer a quorum.
- Barb Lemmer moved to insert verbiage for unification of dues that was just adopted into the bylaws proposed revisions; seconded by Matt May. The vote will be emailed to the 17 delegates within 15 days (by October 6), as stated in Article XIV of IACTE current bylaws.
- Greg Krawiec presented proposed bylaws revisions that had been worked on by himself, Sandy Miller, Karen Van De Walle, and Greg Kepner. The current bylaws are dated 2006. Barb Lemmer moved to approve the proposed bylaws revisions; seconded by Matt May. The vote will be emailed to the 17 delegates within 15 days (by October 6), as stated in Article XIV of IACTE current bylaws. * Bylaws revision motion passed by electronic vote.

Dan Kiley made a motion to adjourn the meeting at 5:20 p.m.; seconded by Matt May. Motion carried.

Conferences:

Last year's conference was cancelled due to the pandemic. This year we have scheduled the day before the ACTE Conference. We are offering special discount for attending the two conferences and are anxious to see if this has a positive effect on attendance for both.

Professional Development being offered as part of our conference will be workshops from DMACC lowa Culinary Institute and Fashion/Interior Design, FCCLA, and Count The Kicks. Breakouts will be offered to teachers with a goal to offer something of interest in all strands of FCS.

Achievements in the past year.

We have begun to work on updating our By Laws and Key Leader responsibilities. This process will continue into next year incorporating new changes to the By Laws of Iowa ACTE.

DE consultant gave Prairie Lakes AEA FCS teachers guidance on RPP and FCCLA. Organized by key leaders in prairie lakes.

Making progress on offering FCS Hospitality & Tourism in Des Moines & Ames schools. Iowa Travel Industry Partners are considering sponsoring person to promote the American Hotel & Lodging Educational Institute's Hospitality & Tourism Management Program in Iowa schools much like May Schaben does for the Iowa Restaurant Association and their ProStart Program.

FCCLA nationals were hybrid this year late July. Student and adviser training sessions were offered. We had chapters compete online and some in person.

IHEA highlights for 2020-2021

Like so many of us and so many organizations, COVID-19 impacted the IHEA (Iowa Health Educators Association) We can definitely all agree that it has been challenging to say the least!

At IHEA, we tried to look and do things a bit differently and tried to think outside the box and be able to attract and keep current members active and attempt to still bring in new members. Typically, we have a large in-person multi day conference held in June each year. In light of COVID, we knew we could not offer a face to face option, so as a board we decided to try something different, and create small multi part webinars instead.

Our first 3-part webinar was held November 3, 10 and 17, 2020. The title was the "Status of Health Care in America" and was led by Kathy Dolter, PHD, LTC, US Army (Ret), Dean College of Nursing Kirkwood Community College

Our second 3-part webinar was held on April6, 13 and 20, 2021. The title was "Resilience Leads to new Discoveries" and featured Ebe Boetcher, RRT, LMT and Adjunct Faculty, as well as a panel of people that had been affected by COVID, through death of loved ones, and being ill as themselves, and the lessons in resilience they each learned.

Cost of webinar was held at a reasonable rate of \$35 for non-members (the non-member cost included a dual membership with IHEA and IACTE. Members were \$20, and nursing contact hours were offered for \$15.

Between both 3-part webinar series, we shared a total of 51 registrants, and we were able to partner with IACTE as a dual membership offering, and contributed approximately 51 members to IACTE membership rolls as well.

Stay tuned for 2022, as we are hoping and planning for our annual IHEA conference to be back, face to face. In addition, we also hope to have the IHEA scholarships and awards back on track for 2022!

Executive Director Annual Report

State of the State Report July 1, 2020 - June 30, 2021

Despite the unique challenges of the pandemic, 2019-2020 was a tremendous success for the Iowa Association for Career and Technical Education. We carried out our Program of Work with integrity and perseverance, thanks to our members and dedicated leaders! We had an active Board of Directors with a full slate of officers and division representatives which held monthly Zoom meetings and one in-person meeting July 9, 2020. We held a successful virtual annual conference on September 22 for 118 attendees, had one CTE Presidential Scholar, participated in several advocacy events involving school administrators, school counselors, and six U.S. Legislators during National Policy Seminar. A committee worked many hours to update the bylaws last edited in 2006. We investigated the possibility of Unification and plan to bring it to the House of Delegates for the question. Iowa Industrial Technology Educators Association (IITEA) came back as an active division with membership and held a professional development conference. Work-based Learning was added as a new division. We have enthusiasm for change to make our organization better while striving to meet the evolving needs of our members, which continues to push us forward advancing CTE. Even in these pandemic times we continue to progress and remain highly active.

Our five-point Program of Work, models ACTE's program of work/strategic plan.

1. Member Value and Engagement

Membership: We had 468 dues-paying members, which was 78 less than the previous year. We continually work to increase membership. IAAE – 165 members, IBEA – 97 members, IFCSE – 54 members, IHEA – 45 members, IITEA – 46, WBL – 22 and 39 others (undeclared, administrators, or other). We look for record breaking membership numbers next year with all divisions holding conferences once again.

Division Conferences: Greetings were brought in person to the IAAE conference and virtually to the WBL conference. Several divisions did not host a conference due to the pandemic. Support of programs and activities comes from members understanding the purpose and significance of each. Continuing to build relationships and give support to divisions is a priority.

Professional Development:

The Virtual Iowa ACTE 2020 Best Practices Conference produced by ACTE was held Sept. 22, 2020, with 118 Registered, 31 Sessions, 12 Exhibitors, 4 CTSOs. Keynote was Scott Stump, Assistant Secretary for Career and Technical Education US Department of Education. Featured speakers were Ann Lebo, Director, Iowa Department of Education; Doug Major, ACTE President; Michael Connect, ACTE Associate Deputy Executive Director Outreach & Partner Development; and Dennis Harden, Iowa Department of Education Bureau Chief.

The **ACTE CareerTech VISION Conference** was held virtually December 1-4, 2020. The Region III Policy Committee Meeting, NEDA (National Executive Directors Association) meeting, State ACTE directors with State CTE Directors Meeting, and Board of Directors Meetings were all held virtually, two weeks prior. During the State Leadership Session, Iowa ACTE received the 2020 QAS Award. This award is for state associations that meet the quality standards set by ACTE.

ACTE Region III Hybrid Conference was held in Mystic Lake Casino Hotel, Prior Lake, MN, June 16-18, 2021. Theme was: Be Bold! Head North! Explore the Power & Potential of Partnerships. The conference provided many opportunities for members of the six-state region to attend great sessions, network, tour companies and be in-person once again.
