Legislative:

For the last legislative session, Alaska CTE board of directors wrote a letter of support to the state for expanding support of apprenticeship programs as a part of the larger Work Based Learning system for students statewide. We submitted a signed federal letter of support in conjunction with other ACTE chapters for expanding Pell Grant opportunities to shorter-term education and training programs. We are tracking the progress of our support and we will continue to update you as we learn more from our state and federal legislators.

Coming up:

The AK ACTE board will continue working with other state ACTE chapters as well as local state departments and school districts to help identify issues in WBL policy in Alaska. Students should be able to explore job opportunities through internships and apprenticeships. The barrier to providing access to skilled labor training and jobs are tight age restrictions for students who are under 18 years of age. The AK ACTE will continue working hard on bringing key players and stakeholders back to the (zoom) table and bring in support from states that have been successful to see how we can help change the future of WBL across Alaska.

the Alaska ACTE State Professional Development Conference to be held in Anchorage at the Hotel Captain Cook on Oct. 17–18.


