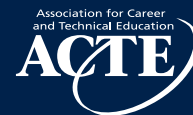


ACTE's Quality Framework

Your Tool for Program Improvement



Through its ongoing High-quality CTE Initiative, ACTE has developed an evidence-based Framework to describe the key components of a high-quality CTE program of study. The *ACTE Quality CTE Program of Study Framework*[™] contains 12 primary elements and 92 criteria, along with wrap-around system supports, that are essential for CTE program quality.

An accompanying self-evaluation tool, available in electronic and print formats, can be used by secondary and postsecondary CTE educators and stakeholders to evaluate progress in implementing the elements of high-quality CTE programs; inform broader program evaluations, such as the Perkins V comprehensive local needs assessment (CLNA); and shape future professional development and program improvement activities.

Ways to Use the Framework

Educator Preparation

Teacher educators can use the Framework to identify key topics to address within CTE educator preparation programs.



Professional Development

CTE administrators and educators can use the Framework and self-evaluation to identify professional development activities that will support program growth and improvement.



New Instructor Support

New CTE instructors can use the Framework to reflect on the components of a high-quality CTE program and set goals for implementing quality elements in their classrooms.



Perkins V CLNA

CTE leaders can use the Framework self-evaluation to inform responses to questions in a state's CLNA template and target resources where most needed.



Awards and Recognition

CTE leaders can use the Framework to recognize CTE programs that demonstrate quality characteristics or have improved their quality.
