At the annual Agricultural Education In-service in Indianapolis, IN, on January 23 and 24, members of the Association for Career and Technical Education (ACTE) participated in informative sessions. The Ag Ed Policy Committee members hosted a Q/A segment focused on the National Quality Program Standards (NQPS), explaining its origins, purpose, and significance. They emphasized the NQPS's role in aiding state-level development of school-based agricultural education programs and challenged ACTE members to assess the hallmarks of exemplary agricultural education programs across different regions and states.

On February 6, 2024, I led a virtual meeting of the AgEd Policy Committee. A key agenda item was the endorsement of the revised Agricultural Education Policy Manual. The meeting also served as a platform to disseminate updates from ACTE and highlight forthcoming events and conferences. We reviewed the advancements in updating the Agriculture, Food, and Natural Resources curriculum standards, a project spearheaded by the policy committee (aka The National Council for Agricultural Education). Furthermore, the committee deliberated on initiating a national effort to foster a sense of belonging within school-based agricultural education programs. This sparked a conversation about the committee's (referred to as The Council) role in cultivating an inclusive culture throughout agricultural education. To address this, a subcommittee was formed to outline the preliminary steps for further discussion and actions aimed at this initiative.

Multiple topics within Policy Committee (aka The Council), including social media insights, committee work for 2024, SAE for All, CASE 4 Learning, 2024 Council Directory updates, and current Council bylaws (updated 9/12/23) were reported on. The next meeting of the policy committee is scheduled for April 16, from 4 to 5:30 P.M. EST, and will be conducted via Zoom.
