### JROTC Leadership Pathways, Lt. Colonel Richard Crossley; Lt. Colonel Robert (Frank) Barrow JROTC programs across America are gearing up to participate in the upcoming REC VEX Robotics

JROTC programs across America are gearing up to participate in the upcoming REC VEX Robotics Worlds Competition in Dallas, Texas this upcoming Spring. JROTC has partnered with REC (Robotics Education Competition Foundation) and has its own separate league. US Army Cadet Command has sponsored participation in this extraordinary event. In addition, the REC Aerial Drone Competition (RADC) National Meet will be held later this Spring as well. JROTC Cadets are just beginning to get involved with this STEM activity as well.

This past Fall, Cadet Command sponsored a National Raider Competition at Fort Knox, Kentucky and all service components were invited. It was the first to be held at Fort Knox and several thousand cadets participated in this rigorous and physically demanding event. The events included a one-rope bridge over a stream, five-kilometer team run, obstacle course, and a series of other challenges. It was the highlight of the Fall Semester for many of our students.

Finally, the JROTC STEM Leadership Academy (hybrid) in Mobile, Alabama continues to be funded by a Six-million dollar grant from the Department of Defense STEM organization which intends to replicate this model at ten other districts across America from Savannah, Georgia to San Diego, California. This model has a focus on STEM and workforce development and includes all of the traditional summer camp events normally conducted at JROTC summer camps like leadership opportunities, rappelling, drown-proof training, land navigation, and physical fitness.
