A. Strategic Direction Contributions

Since the last Board meeting, what have you and your policy committee members done to represent and serve your Region/Division members in the following areas?

Member Value & Engagement

Ex. Growing Membership // Engaging Members // Recruiting New Leaders // Developing Leaders

- Added one additional Policy Board member to increase the total to 14 members.
- Secured a Policy Chair for the eTED Division and also filled all three standing committee vacancies.
- Promoted leadership opportunities (ACTE Fellowship & VP Elect Position) in spring newsletter.
- Created handout materials for the Region III conference in LaCrosse, Wisconsin in June. Materials developed were to increase awareness and membership for the eTED Division in the six states that make-up Region III.

Professional & Leadership Development

Ex. Sourcing Topics and Presenters (for Conferences & Online) // Evaluating Sessions

- Reviewed and secured 20 eTED Division presentations for VISION 2018 in San Antonio.
- Provided information to division members related to online and virtual courses being offered through ACTE and partner companies and organizations.
