Be sure to check out the FCS Educator Day resources. New items have been added for you to use in your classroom in February.




#### National Association of Teacher Educators for Family & Consumer Sciences (NATEFACS)




deputy assistant secretary for community colleges in the Office of Career, Technical and Adult Education at the U.S. Department of Education, as the keynote speaker.
