IV. Alisha Hyslop's Legislative Update

- a. This fall, Congress' focus has been on elections.
 - i. Will reconvene after the election
 - ii. The anticipated largest focus will be on re-appropriation to avoid another shutdown.
 - iii. Outreach to new members of Congress would be a focus for ACTE to build relationships.
- b. The Department of Education largely focuses on the FAFSA process to be improved. FAFSA is in the second phase of improvements for a 12/1/24 rollout.
- c. In CTE specific context, there is a proposed update to Perkins state plans and accountability measures. ACTE expresses concerns about the implications to states, districts, and colleges. Some proposed changes to data reporting would require a new Perkins state plan by 2026 even if a new plan were recently completed.
